



2021-2022 FUNDRAISING & VOLUNTEER AGREEMENT

Tuition and Fees alone do not cover the cost of educating a student at SJA. The actual cost of educating a student in 2021-2022 is \$1,980 higher than the amount charged for tuition and fees. SJA does not receive any federal, state, local or government money. For this reason, SJA has a formal fundraising and volunteer program. The revenue generated by this program maintains and sustains the exceptional high school experience that is offered at St. Joseph Academy. We ask all our families to support these efforts for the benefit of their children and our school. The two options listed below outline the required volunteer hours and required fundraising participation for each family for the 2021-2022 school year.

☐ Option 1

1. Provide a total of 25 volunteer hours during this school year, 10 volunteer hours must be spent on Auction projects. For single parents, the requirement is 12.5 hours; 5 hours for Auction projects. Each family is responsible for keeping a record of their volunteer hours using the SJA Volunteer Hours Sheet. Each family will be billed at the rate of \$20 for each hour not met and \$50 for each Auction hour not met. Deadline for Volunteer Hour Sheets: **April 13, 2022.**
2. Sell or purchase 2 SJA Spectacular Dinner Auction tickets.
3. Donate at least one Auction item with a minimum value of \$50.
4. Obtain at least one Auction sponsorship or advertisement.

Those who would prefer may elect to pay a \$1,200.00 Fundraising and Volunteer Fee and be exempt from all the above requirements.

Please Note: If a student withdraws prior to year-end, the Fundraising and Volunteer Fee will be pro-rated monthly: \$120.00 per month for every month the student has been in attendance.

Volunteers assist in providing educational and other services to the students, faculty, and staff under the direction of the Administration and Director of Advancement. The Diocese requires all school volunteers to be fingerprinted and all drivers' licenses cleared for anyone transporting students. Those transporting students must carry \$300,000/\$100,000/\$50,000 in liability insurance coverage. The Diocese of St. Augustine requires all volunteers to attend the Protecting God's Children Workshop and a fingerprint renewal every 5 years. Please provide us with a copy of your clearance letter and your certificate for Protecting God's Children.
